

ORDINANCE NO. 2014-10

ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER IV, "GENERAL LICENSING",  
SECTION 4-1.8 "FEES ESTABLISHED" FOR BUSINESS LICENSES OF THE REVISED  
GENERAL ORDINANCES OF THE BOROUGH OF RED BANK

offered the following resolution and moved its adoption on first reading:

**BE IT ORDAINED** by the Governing Body of the Borough of Red Bank that Chapter IV, "Business Licensing", Section 4-1.8 "Fees Established" for Business Licenses. of the Revised General Ordinances of the Borough of Red Bank, be amended and supplemented as follows:

**SECTION ONE:** Section 4-1.8( "Fees Established) of Article IV ( "General Licensing" ") of the Revised General Ordinances of the Borough of Red Bank is amended and supplemented as follows ( stricken text denotes deletions, underlined text denotes additions):

§ 4-1.8. Fees established.

License fees shall be as follows:

- a. Auction stores, \$15 per day.
- b. Auctioneers, \$10 annually.
- c. Billiard and pool tables, other than of fraternal or religious organizations, \$10 per table each, annually.
- d. Dance halls, including cabarets and any public place where food is served accompanied by dancing, other than charitable exhibitions, \$100 annually. No license shall be issued for any dance hall unless the premises comply with and conform to all laws of the United States, State of New Jersey and the ordinances and regulations of the Borough, and are properly ventilated and supplied with sufficient toilet conveniences, and are in the judgment of the Chief of Police, a sufficient and proper place for the purposes for which they are to be used.
- e. Distributors of circulars for commercial advertising, samples and any other similar writings as follows:
  - (1) Fifteen dollars for distribution over a period not to exceed three days.
  - (2) Twenty-five dollars for distribution over a period not to exceed 10 days.
  - (3) One hundred dollars for annual distribution license.
  - (4) Distribution in cars, moving or standing, on private property or in public streets or parking areas is prohibited.
  - (5) Advertising material shall not be distributed on any street or other public place.
- f. Miniature golf courses, \$25 annually.
- g.. Theatres, including places where moving pictures are shown, \$100 annually.
- h. Pawn brokers, \$50 annually.
- i. (1) Retail food establishments on the basis of the following:

<b>Square Feet</b>	<b>Fee</b>
Up to 1,000	\$25
1,001 to 2,000	\$50
2,001 to 3,000	\$75
5,001 to 10,000	\$150
10,001 to 20,000	\$200
20,001 and over	\$300

(2) ~~Itinerant retail food establishment: \$25.~~

Shall be those licensing fees as fixed by the Monmouth County Regional Health

Commission for Retail Food Establishments.

- j. Seasonal and Farmer's markets, \$350 per season.
- k. All other businesses: \$25 annually.

**SECTION TWO:** Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of Chapter IV, “General Licensing” of the Borough’s Revised General Ordinances, are ratified and remain in full force and effect.

**SECTION THREE:** If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION FOUR:** This Ordinance shall take effect immediately upon its passage and adoption according to law.
